## The Next Steps

The application will now be decided by the Independent Planning Commission (IPC). Details on the IPC can be found at <https://www.ipcn.nsw.gov.au/>

Once a proposed development is assessed by the DPPI and provided to the Commission for decision, the Chair of the Commission will appoint a panel, typically comprised of between one and three Commissioners, that will:

- hold targeted meetings with the developer, DPPI, the local council, and others,
- hold a public meeting where appropriate, or a public hearing if directed by the Minister,
- take and consider written public submissions on the proposed development,
- make a determination based on legislation and policy to either refuse or approve the development,
- publish a Statement of Reasons explaining the reasons for the decision.

OX2 will distribute a newsletter to neighbouring properties once the panel has been appointed and further information is available regarding a public meeting or hearing. If you wish to receive this communication via email, please contact us with your details.

# Community Update

## Community Benefits

OX2 are working closely with Muswellbrook Shire Council to deliver a **Community Benefit Program**.

**For the life of the project, an annual fund will be delivered via Council through community grant programs, training and scholarships and a neighbour benefit contribution.**

The General Terms of a Voluntary Planning Agreement (VPA) were approved by Muswellbrook Shire Council on the 14<sup>th</sup> May 2024. These include:

1. A monetary contribution of 'the greater of \$850/MW or as per finalised 'Benefit Sharing Guideline' installed, paid annually, and adjusted for consumer price index';
2. Annual instalments spent in the following ratios:
  - a. 10% Specialist staff contribution.
  - b. 45% Muswellbrook Shire Community Benefit Fund contribution.
  - c. 45% Neighbour benefits contribution (administered via Council).
3. Council is supportive of assisting with the 'deliver local benefits' as rate rebates to the properties nominated by the Proponent.
